7/21/13 - NU BOP. TOOH with tubing and AS-1 packer. Run gauge ring to 8,100 ft. Set CIBP at 8,082 ft.
7/22/13 - Tagged CIBP at 8,082 ft. Circulated hole with fresh water. Spotted 25 sacks Class H cement from 8,082 ft to 7,797 ft. WOC 4 hours. Tagged TOC at 7,797 ft. Circulated hole with 3 percent KCL. Tested 5-1/2 inch 17 lb casing to 500 psi and held for 30 mins, held good. No BLM personnel on location at time of pressure test or tagging of cement.
7/23/13 - Perf'd Cisco 7,446 to 7,528 ft (62 holes) and acidized with 4500 gals 15 percent NEFE HCL inhibitor acid with 100 ball sealers.
7/28/13 - RBP set at 7,400 ft. Tested to 1000 lbs. Spotted 2 sacks sand.
7/29/13 - Perf'd Wolfcamp 6,009 ft to 6,042 ft (46 holes) and acidized with 3500 gals 15 percent NEFE with 90 ball sealers. AS-1 packer and 2-7/8 inch 6.4 lb L-80 tubing at 5,959 ft.
