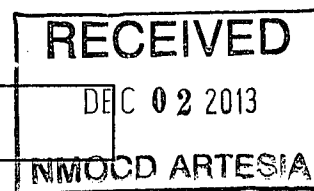

 8/20/13 - Set 4-1/2" CIBP at 8,070'. TIH with packer to isolate hole in casing. Found bottom hole between 5,622' to 5,653'. Tested casing from 5,653' down to CIBP at 8,070' to 1500 psi, held good. Found top hole between 1,491' to 1,523'. Released packer and POOH.
 8/21/13 - TIH with 4-1/2" packer and RBP. Set RBP at 5,555'. Tested to 1500 psi, held good. Well has multiple holes in casing at 6,250' and possibly at 250'.
 8/26/13 - ND BOP. Plan to plug and abandon this well.
