The NSLU #35 is an inactive producer with stuck tubing. Boaz Energy proposes the following:

- MIRU and freepoint tubing to see where it's stuck
- If its stuck low then RIH with wireline and chemical cut right above the fish, POOH with free tubing
- PU new 2-3/8" tubing as needed and model R packer and TIH
- Set packer above fish and test backside to 500 psi
- set a RBP above fish and perforate the Queen Formation from 2429- 2453 with 4 spf and frac down 3-1/2" frac string with 2000 gals 15% HCL with 10% xylene, 150,000 gallons SW and 30,000 lbs of sand
- If Queen test is not economic then Boaz will squeeze the Queen perms try to grab the fish, RTP in the Grayburg-SA
