WE ARE CURRENTLY HAVING DIFFICULTY CONFIRMING OWNERSHIP IN THIS WELL. WE HAVE TWO BROKERS WORKING THROUGH BOTH THE FEDERAL AND COUNTY RECORDS, BUT DON'T ANTICIPATE A RESOLUTION REGARDING WORKING INTEREST OWNER PERCENTAGE FOR SEVERAL WEEKS. IN ADDITION TO THAT, ONCE WE CONFIRM OWNERSHIP, THE PARTNERS WILL NEED TO BE BALLOTTED FOR THIS WORK. LOOKING THROUGH THE JOA, THERE IS NO LANGUAGE REGARDING A TIMEFRAME OR PENALTY FOR NON-RESPONSE ON A WORKOVER BALLOT. THIS BEING THE CASE, WE WOULD LIKE TO PLAN ON 60 DAYS TO COMPLETE THE BALLOTING PROCESS. ONCE THAT IS COMPLETE THE WORK CAN BE SCHEDULED ON ONE OF OUR RIGS. THEY ALL HAVE A 30 DAY LOCKDOWN PERIOD AND ARE RUNNING ABOUT 60 DAYS OUT SO WE ANTICIPATE COMPLETING THE WORK BY 07/01/2014. THIS WOULD ALSO KEEP US FROM DISTURBING THE AREA DURING PRAIRIE CHICKEN SEASON.
