Additional Comments: A deep bury pit 15' x 20' x 15' deep will be dug inside the reserve pit area and lined with a 12 mil liner. All drilling pit material will be placed inside the deep bury pit. The drilling pit material will be encapsulated by folding the 12 mil liner in on the sides and top of pit and then installing a 20 mil liner on top. Drilling pit area will then be leveled to cover the deep bury pit. At least 3' of top soil will be put on top of the drilling pit area and the terrain returned to as close to original condition as possible.
