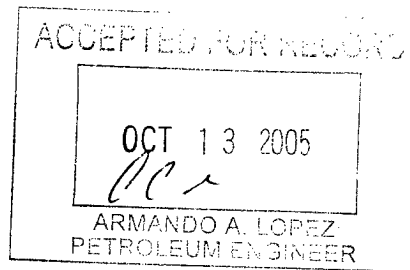

Tailed in with 750 sx PVL with 1#/sx D44 + 4#/sx D24 + .3% D167 + .2% D65 + .1% D13 (yld 1.41, wt 13). Cement circulated to surface.
