Detailed herein is a summary of activities at the site by Diversified Field Service, Inc. (DFSI). The well and caliche pad at this site were previously removed by Blade Services. Following the removal of the well and caliche pad, DFSI personnel removed caliche from the surface of the lease road for future use. On August 20, 2013, DFSI tilled the site, and broadcast a total of 100 pounds of Lesser Prairie Chicken seed over the entire area. The seed was then tilled into the soil, restoring the site to a natural state per BLM guidelines (See Site Photographs).








Former location of Pad and removal of Lease Road
