Casing/Cement Program: Additional Comments

Plan to drill a 17-1/2" hole to 695' with Fresh Water. Run 13-3/8", 54.5#, J-55 csg and cmt to surface. Drill 12-1/4" hole to 2,960' with Brine, and run 9-5/8", 36#, J-55 and cement to surface. Drill 8-3/4" vertical and curve to 8,700'. Drill 7-7/8" lateral with cut brine to approx 15,193' MD. Run a 7", 29#, P110 by 5-1/2", 17#, P-110 tapered string of csg and cement to 2700'.

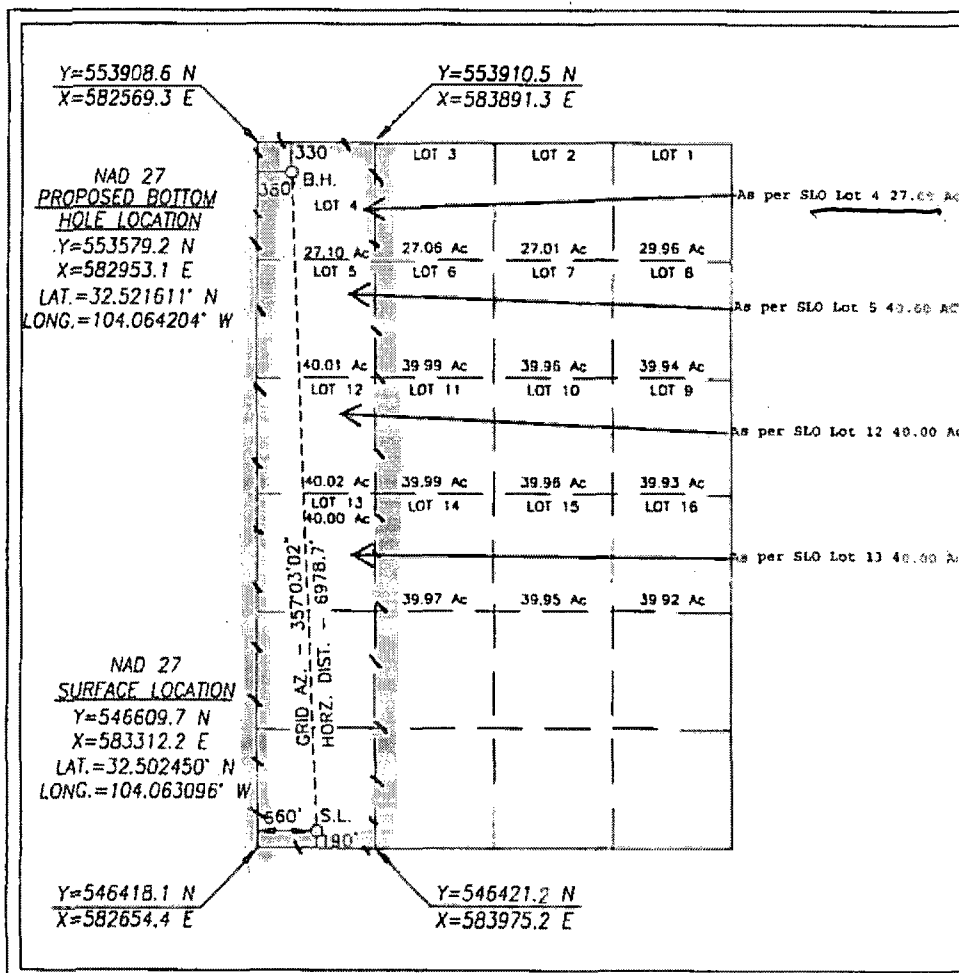
