 3/6-8/14 - Pressure tested casing to 3000 psi for 30 mins, held good. Pumped 1000 gallons 20% NEFE HCL acid at 2 BPM at 5500 psi. Flushed with 150 bbls fresh water followed by 240 bbls 3% KCL with CRW-132chemical.
 4/18-25/14 - Perforated Yes 3,040' - 7,381' (560 holes). Acidized with 56,900 gallons 20% HCL acid, frac with a total of 5,672,413# 100 Mesh, 40/70 Brady, 40/70 Premium White sand. 2-7/8" 6.4# J-55 tubing at 2,265'.
