The Gissler A 25 developed a split in the 7? 23# J-55 casing from 3090? ? 3096? (San Andres) during a frac stimulation in the lower Blinbery (Yeso) the week of June 12th, 2014. The casing split has been isolated with a plug below it and an injection rate of 3 BPM at 470 psi has been established with clean water. There are two other frac stages in the Yeso to be done at depths of 5200? and 4600? so a 4.5? work string will be used to frac down on the two future completions.

Burnett requests permission to have 400 sx cement on location and begin the squeeze with 200 sx and let the formation determine how much to pump. A 500# rolling squeeze would be ideal. We will use the same cement that was used for the deepening: 50/50 P/C+5%PF44(BWOW)(Salt)+2%PF20(Bentonite Gel)+0.7%PF606(Fluid Loss)+0.2%PF65(Dispersant)+0.4#/skPF46(Defoamer) 25% excess Density 14.3ppg 1.34CF/sk Yield, 6.064 gal/sx water

1. Before casing or a liner is added, replaced, or repaired prior BLM approval of the design is required. Use notice of intent Form 3160-5.
2. Subject to like approval by the New Mexico Oil Conservation Division.
3. **After the cement squeeze and frac stimulation, perform a (charted) casing integrity test of 500 psig. Verify all annular casing vents are plumbed to surface and those valves open to the surface during this pressure test. Pressure leakoff may require correction for approval. Include a copy of the chart in the subsequent sundry for this workover.**
4. **Provide BLM with an electronic copy (Adobe Acrobat Document) (post cement squeeze at 3090') cement bond log record (7" and 5 ½" csg) from 5700 or below to top of cement.** The CBL may be attached to a [pswartz@blm.gov](mailto:pswartz@blm.gov) email. The CFO BLM on call engineer may be reached at 575-706-2779.
5. Surface disturbance beyond the existing pad shall have prior approval.
6. A closed loop system is required. The operator shall properly dispose of drilling/circulating contents at an authorized disposal site. Tanks are required for all operations, no excavated pits.
7. Functional H<sub>2</sub>S monitoring equipment shall be on location.
8. 2000 (2M) Blow Out Prevention Equipment to be used. All BOPE and workover procedures shall establish fail safe well control. A ram system including a blind ram and pipe ram(s) designed to close on all of the work string(s) used is required equipment. Manual BOP closure (hand wheels) equipment shall be installed regardless of BOP design. Function test the installed BOPE to 500psig when well conditions allow. Related equipment, (choke manifolds, kill trucks, gas vent or flare lines, etc.) shall be employed when needed for reasonable well control requirements.
9. All waste (i.e. trash, salts, chemicals, sewage, gray water, etc.) created as a result of work over operations shall be safely contained and disposed of properly at a waste disposal facility. No waste material or fluid shall be disposed of on the well location or surrounding area. Porto-johns and trash containers will be on-location during fracturing operations or any other crew-intensive operations.
10. Workover approval is good for 90 days (completion to be within 90 days of approval). A legitimate request is necessary for extension of that date.
11. File intermediate **subsequent sundry** Form 3160-5 within 30 days of any interrupted workover procedures and a complete workover subsequent sundry.

12. Submit the BLM-Form 3160-4 **Recompletion Report** within 30 days of the date all BLM approved procedures are complete.
