

Describe Area Affected and Cleanup Action Taken.* The spill was contained within the earthen containment around the tank battery. All of the free product was removed with a vacuum truck. Following initial response activities, the release was remediated per NMOCD guidelines in conjunction with two others releases that occurred on 5/13/10 & 7/7/10 and affected the same area. Please reference the attached *Remediation Summary & Risk-Based Site Closure Request* for details of remediation activities and laboratory analytical results from confirmation soil samples.
