

BOPCO will also run a CBL on this casing string prior to running the next casing string and submit to the BLM.

Request for variance is approved with the following conditions of approval:

1. Perform a pressure test on the 9-5/8" x 13-3/8" annulus (chart recorded) to 500 psi for 30 minutes. Pressure test can be done any time prior to running the next casing string.
2. Make arrangements 24 hours before the test for BLM to witness. In Eddy County email Paul R. Swartz pswartz@blm.gov or phone 575-200-7902, if there is no response, 575-361-2822. If no answer leave a voice mail or email with the API#, purpose, and a call back phone number.
3. As indicated in the sundry run a CBL on the 9-5/8" casing string and provide a copy to the BLM for evaluation prior to running the next casing string. Provide BLM with an electronic copy (Adobe Acrobat Document) cement bond log record of the CBL.
4. The 9-5/8" x 13-3/8" annulus is required to be monitored (for life of the well) for loss of casing integrity. Operator shall submit on a sundry the type of casing annulus monitoring system they are using. Operator to maintain records of their monitoring system and provide to BLM upon request.
