Old Drilling Pit will be reclaimed with additional soils (materials used will be from pad down size, if a better grade of topsoil is needed native/like soils will be brought in). Material will then be capped on top of old pit area and contoured to grade of surrounding area (1 ft of caliche with 2 ft of native/like soil on top of caliche). Impacted soils will be excavated and hauled to an approved facility. Excavated soils south of the well head will be back filled with existing material from pad down size. The pad will be down sized to accommodate the use of a pulling unit. The old flow line will be removed to a location east of the existing access road.
