Set bridge plug at 4211 feet. Pump 25 sacks cement on top of BP. RIH with 113 joints of tubing and pump 35 sacks cement. Tag cement at 3,218 feet. Pull free point stretch; free point figured at 2,421 feet. TOOH with 86 joints 5 1/2 inch casing, tallied at 2,310 feet. RIH with tubing to 2,381 feet. Pump 100 sacks cement. Tagged plug at 1,980 feet. RIH with 47 joints tubing to 1,475 feet. Pump 40 sacks cement. Tag plug at 1,340 feet. RIH with 18 joints tubing to 561 feet. Pump 40 sacks cement. Tag plug at 414 feet. RIH with 3 joints tubing to 100 feet. Pump cement plug to surface.
