11/10/14..MI & spud 12 1/4" hole. TD'd hole @ 820'. Ran 820' of 9 5/8" 36# J55 LT&C csg. Cemented with 180 sks Class C w/additives. Mixed @ 14.2 /g w/ 1.64 yd. Tail with 400 sks Class C w/2% CaCl2. Mixed @ 14.8 #/g w/ 1.34 yd. Plug did not bump. Circ 180 sks of cmt to the pit. At 7:00 AM 11/12/14, tested BOPE & csg to 1500# for 30 minutes, held OK. Drilled out with 8 3/4" bit.

11/14/14. TD'd 8 3/4" hole @ 2945'. Ran 2735' of 7" 26# J55 BT&C Csg. Cemented with 250 sks Lite Class C (35:65:4) with additives. Mixed @ 11.9 /g w/ 2.48 yd. Tail with 300 sks Class C Neat. Mixed @ 14.8 #/g w/ 1.32 yd. Plug down @ 9:15 PM 11/14/14. Circ 160 sks of cmt to the pit. At 8:00 P.M. 11/16/14, tested BOPE & csg to 1500# for 30 min, held OK. Drilled out with 6 1/8" bit.
