2/3/14 - Contacted Richard with BLM at 12:30 with intent to plug well back. TIH with 5.7 inch gauge ring and junk basket to 7,710 ft. Set 7 inch CIBP at 7,700 ft. Tagged CIBP and loaded hole with 197 bbls fresh water. Pressure test casing to 500 psi for 15 mins, held good.
2/4/14 - Pumped mud gel and spotted 25 sacks Class H cement on top of CIBP at 7,700 ft. Est TOC at 7,563 ft. WOC. Tagged cement plug at 7,500 ft, Joe Salcido with BLM witnessed tag. Spotted 65 sacks Class C with 2 percent Cal across DV tool and Wolfcamp. Est TOC at 5,682 ft. WOC. Tagged cement plug at 5,685 ft, Joe Salcido witnessed tag. Spotted 30 sacks Class C. Est TOC at 4,565 ft.
2/5/14 - Tagged cement plug at 4,542 ft. Circulated 115 bbls fresh water. Logged well from 4,536 ft to surface with 1000 psi on log. Pressure test casing to 3000 psi and ran chart for 30 mins. Dropped down to 2900. Lost total of 100 psi, good. Notified Joe Salcido but was not present to witness test. Bled well down. Perf'd Yeso 2,484 ft - 2,796 ft (63 holes). ND BOP.
