This well was plugged as follows:

12/18/14: POH w/ rods. Pump 20 bbls of water down backside with no pressure. POH w/ tubing

12/19/14: Cut off well head and weld on 5 1/2" collar and install swage and valve

12/23/14: RIH w/ tubing to 620'. Pump water down tubing and establish circulation around inside and outside 5 1/2" casing. Pump 55 sack Class C neat plug at 620', lost returns after pumping approximately 35 sx. and POH. WOC 3.5 hrs Run back in hole and found top of plug at 320'. Establish circulation inside and outside of 5 1/2" casing and Pump 75' sack Class C neat plug, SDFN.

12/24/14: RIH and tag plug @ 77'. Pump water and establish circulation inside and outside of 5 1/2" casing. Pump 25 sacks of Class C neat to fill casing and annulus from 77' to surface.

After this well is plugged, a dry hole marker will be installed and the location cleared of junk then remediated as required by the BLM


