

10/15/14 - Tested casing to 3000 psi for 30 mins, good. Pressured casing to 6842 psi opened toe sleeve at 12,281 ft. Pumped 1000 gallons of 15 percent HCL acid, 320 barrels 3 percent KCL with CRW-132.
12/2-3/14 - Perforated Bone Spring 7,955 ft - 12,178 ft (504 holes). Acidized the perforated Bone Spring and toe sleeve with 58,000 gallons 15 percent HCL, frac with a total of 6,371,321 lbs 16/30 RCS and 20/40 White sand.
