Pressure tested plug at 5,431 ft to 1,000 psi for 15 minutes. Held okay. Corrected depth at 5,305 ft. Ran CBL from 5,305 ft to surface. TOC at 1,890 ft. Set 4 1/2 in CIBP at 5,185 ft. Perfed from 5,221 ft to 5,244 ft. Swabbed and flowed well. Making water, no oil or gas. Shut well in and prepared to P&A.
