 2/5/15 - Loaded hole with 10 bbls. Spotted 100 sx Class H Neat cement at 6270 ft. WOC 4 hrs. Tagged at 5878 ft. Circulated 200 bbls salt gel. Spotted 35 sx Class H Neat cement. WOC 4 hrs. Tagged at 5459 ft.  
 2/6-8/15 - EOT at 3585 ft. Spotted 35 sx Class C Neat cement. Calc TOC at 3374 ft. Spotted 35 sx Class C Neat. Calc TOC at 1953 ft. Spotted 40 sx Class C Neat cement. Calc TOC at 1049 ft.  
 2/9/15 - Tagged plug at 1066 ft. Pumped 40 sx Class C Neat cement at 150 ft and circulated to surface. ND BOP. Topped out casing.  
 2/11/15 - Dug out cellar and cut off wellhead. Installed dry hole marker. Filled cellar. WELL
