2. Set a CIBP at 7649' and dump 25 sx Class "H" cement on top of CIBP, this will cover the top of Canyon.
3. Spot a 30 sx Class "C" cement plug from 5370'-5220', this will cover top of Wolfcamp.
4. Spot a 25 sx Class "C" cement plug from 4590'-4440', this will cover top of Abo.
5. Spot a 25 sx Class "C" cement plug from 3164'-3014', this will cover top of Bone Spring.
6. Spot a 25 sx Class "C" cement plug from 1990'-1840', this will cover top of Glorieta.
7. Spot a 25 sx Class "C" cement plug from 1267'-1117', this will cover 9-5/8" casing shoe. WOC and tag.
8. Spot a 30 sx Class "C" cement plug from 150' up to surface.
9. Remove all surface equipment and weld dry hole marker as per regulations.

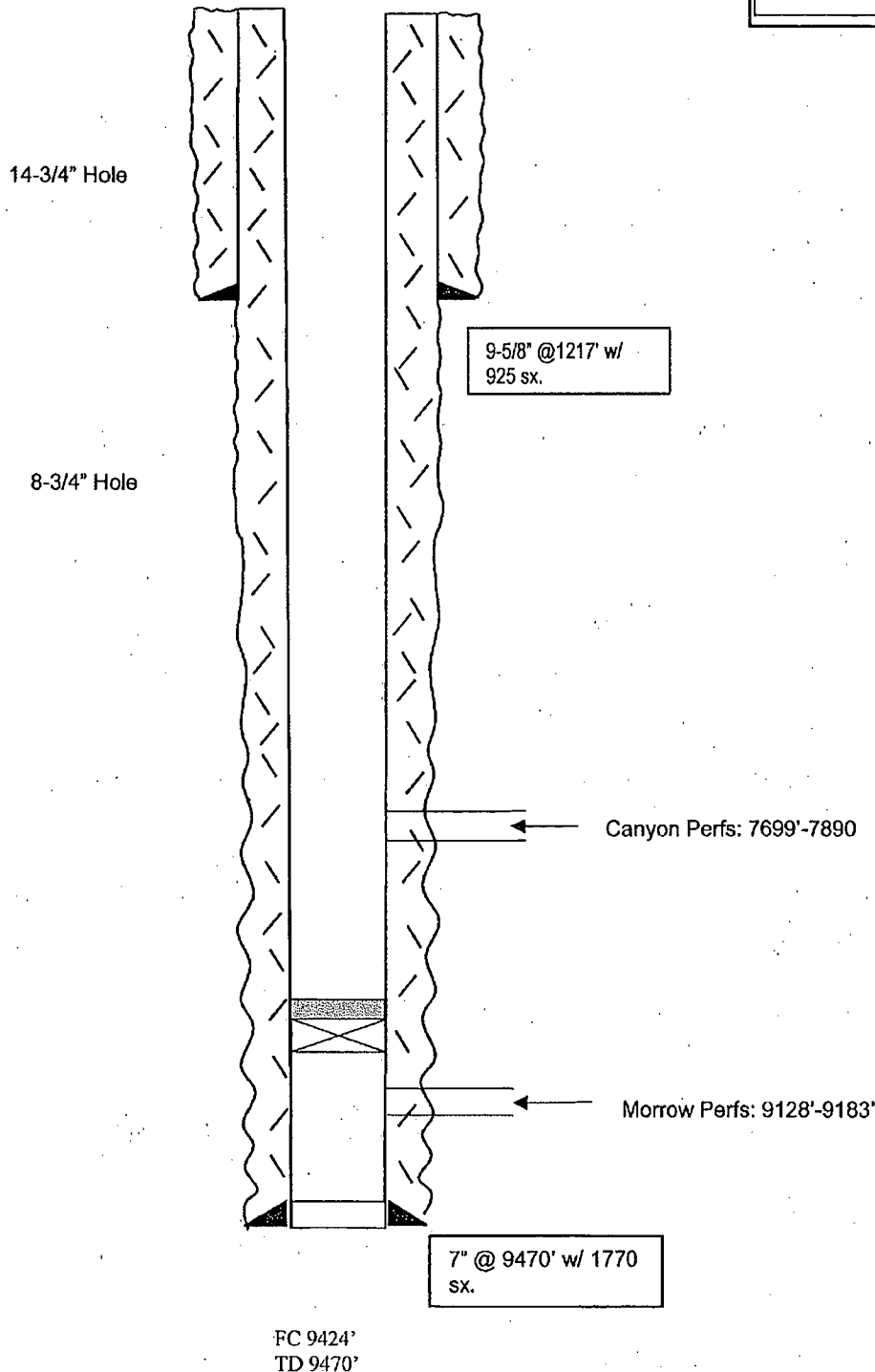

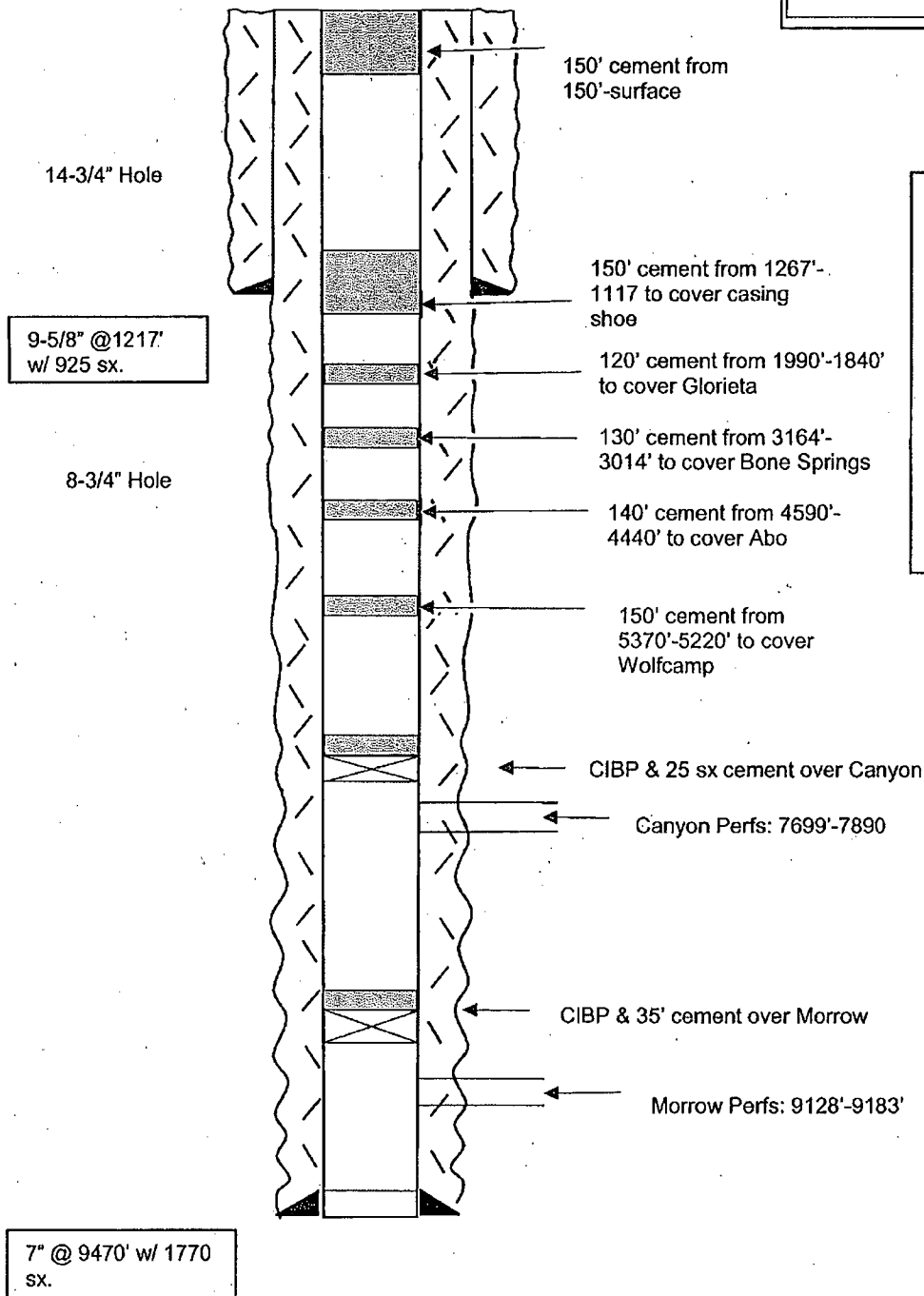
