MOC is currently permitted to run a 4 1/2" production liner with a packer and port system. We request the following change:

Run 4 1/2" cemented liner with packer type liner hanger set @ 7408'. Cement with 210 sks Class C (60:40:0) w/4% MPA5, 1.2%BA10, 10#/skBA90, 5%A10, 1.5% SMS, 1.2% R21. Yield 2.97 cuft/sk @ 11.2#/gal. Mix water 17.46 gal/sk. 500psi compressive strength in 16 hrs.

All other casing depths and types will remain the same.

Original COAs still stand. (Liner is now cemented.)
