There was a 300 BWPD increase, with the highest pressure observed at 1200 PSI, and a standard operating pressure of 250 PSI. Increased production downtime, significant rate volatility. Affecting well was Cimarex operated Hackberry 23 Federal 2H (30-015-42093) in Bone Spring. Well affected Hackberry 23 Federal 1H starting 06/01/14 through 06/05/14. Stimulation pressure was 4500 with a stimulation volume of 6,030,000 pounds.
