07/15/15..MI & spud 17 1/2" hole. TD'd hole @ 167'. Ran 167' of 13 3/8" 54.5# J55 ST&C csg. Cemented with 200 sks Class "C" with 1% CaCl2. Mixed @ 14.8 /g w/ 1.34 yd. Plug down @ 12:30 AM 07/16/15. Circ 34 sks cement to pit. WOC. Tested wellhead to 800#. At 4:30 AM 07/16/15, tested csg & BOPE to 1250# for 30 minutes, held OK. Drilled out with 12 1/4" bit.

07/18/15..TD 12 1/4" hole @ 2524'. Ran 2524' of 9 3/8" 36# J55 LT&C csg. Cemented with 600 sks Class "C" w/additives. Mixed @ 12.5 /g w/ 2.03 yd. Tail w/200 sks Class C w/additives. Mixed @ 14.8#/g w/1.33 yd. Plug down @ 7:00 AM 07/19/15. Circ 151 sks cement to pit. WOC. At 10:00 PM 07/19/15, tested csg & BOPE to 2000# for 30 minutes, held OK. Drilled out with 8 3/4" bit.
