Describe Cause of Problem and Remedial Action Taken.*
A 1/4 inch high pressure hose failed on murphy kill. 35 barrels of produced water was released, 30 barrels being inside the lined containment. The fluid inside the containment was recovered via vacuum truck. The high pressure hose was replaced.

Describe Area Affected and Cleanup Action Taken.*
A vacuum truck was called to the location and was able to recover 30 barrels PW from inside the lined containment. The 1/4 inch hose was replaced.
