6-30-2005 - Moved in and rigged up pulling unit. POOH with rods. Nipped down wellhead and nipped up BOP. Started out of hole with tubing. Shut well in for night.

7-1-2005 - Nipped up Enviro Pan. POOH with tubing. RIH with bit, scraper and tubing to 1600'. POOH. RIH with packer and tubing. Shut well in for night due to storm.

7-2-2005 - RIH with Arrowset 1X packer with K-valve and tubing to 1550'. Tested casing to 500 psi, held okay. POOH with packer and tubing. RIH with CIBP and tubing to 1550'. Set CIBP. Nipped down BOP and nipped up wellhead. Rigged up pump truck. Circulated 50 bbls of packer fluid. POOH and laid down tubing. Rigged down pulling unit.

7-19-2005 - Moved in and rigged up pulling unit. RIH with packer and tubing to 1549'. Tested CIBP to 500 psi, OK. Moved packer up hole to 1186'. Tested casing - leaked. Pulled packer to 1121' and tested casing to 500 psi, held okay. Dropped down 1 joint to 1154'. Tested casing to 500 psi, did not hold. NOTE: Got verbal permission from Mike Bratcher w/OCD-Artesia to set a CIBP at 1121'. POOH with tubing and packer. Shut well in overnight.

7-20-2005 - Rigged up dump bailer and dumped 15' of cement on top of CIBP at 1549'. POOH. RIH with CIBP and tubing and set CIBP at 1121'. Pulled one stand of tubing and tested casing to 500 psi, held okay. Finished POOH with tubing. Nipped down BOP and nipped up wellhead. NOTE: Will schedule MIT for a later date. Rigged down and moved off pulling unit.

10-22-2005 - Rigged up pump truck. Loaded casing with water. Installed pressure recorder and pressured up on casing to 500 psi for 30 minutes, held okay. Please see attached chart for Mechanical Integrity Test conducted on 10-21-2005. WELL IS TEMPORARILY ABANDONED. NOTE: Chris Beadle w/OCD-Artesia witnessed Mechanical Integrity Test.
