10/29/05 TD 17-1/2" hole at 1:00 AM. Set 13-3/8" 48# H-40 ST&C casing at 560'. Cemented with 350 sx Class "C" + 1/4# Flocele + 2% CaCl (yld 1.35, wt 14.8). Tailed in with 250 sx Class "C" + 2% CaCl (yld 1.35, 14.8). Cement circulated to surface. Tested casing to 1000 psi for 30 min. WOC 49 hrs 45 min. Reduced hole to 11" and resumed drilling.
