Spud well at 1:00 am on 12/14/05. Drilled 11-3/4" hole to 972'. Ran 22 jts 11-3/4", 42#, HE, STC casing and set at 972'. Cemented with 400 sx 35:65 Poz C + 6% D20 + 3% S1 + 5 pps D44 + 1/8 pps D130 lead plus 200 sx Class C + 2% S1 tail. Circ 87 sx to surface. WOC 25-1/2 hrs. Tested csg to 1000 psi, held ok. Drilled 7-7/8" hole to 7374'. Ran 30 jts, 17#, J55, LTC and 176 jts 5-1/2", 15.5#, K55, LTC casing and set at 7373'. Cemented 260 sx Lite Crete + 2% D153 + 2 pps D24 + 0.05 gps D604AM + 0.03 gps M45 + 0.04 gps D801 lead (10.2 ppg, 2.64 yld) and 230 sx same for tail (10.5 ppg, 2.27 yld). Full returns. TOC by temperature survey 3300'. Rig released at 12:00 am on 12/28/05.
