12/22/05 - Perforate Wolfcamp 10,308'-10,320', 10,375'-10,390', and 10,446'-10,454' for a total of 213 - .42" holes.
12/27/05 - Acidize Wolfcamp 10,249'-10,454' with 2700g 7-1/2% IC HCL with 200 ball sealers.
12/30/05 - Frac Wolfcamp 10,249'-10,454' with a CO2 foam frac with 482 bbls fluid, 191 tons CO2, 50,000# 20/40 Versaprop. Set packer at 10,150'.
