6-10-2003 - RIH with tubing - did not tag. Spotted 50 sacks Class C Neat cement at 2208'. POOH with 60 joints. WOC 4 hours. RIH with tubing - did not tag. POOH with 20 joints. Shut well in for night.

6-11-2003 - RIH with tubing - did not tag. Spotted 50 sacks Class C Neat cement at 2208'. POOH with 40 joints. WOC 4 hours. RIH with tubing - did not tag. Spotted 50 sacks Class C Neat cement. POOH with 40 joints. Shut well in for night. WOC.

6-12-2003 - RIH with tubing - did not tag. Pumped 2 bags LCM and spotted 50 sacks Class C Neat cement at 2208'. POOH with 40 joints. Shut well in for night. WOC.


6-13-2003 - RIH with tubing and tagged plug at 2068'. POOH with tubing and unplugged tubing. RIH with tubing to 2060'. Pumped 130 bbls plugging mud. Pulled up hole to 896'. Shut well in for night.

6-14-16-2003 - RIH with tubing - did not tag. Spotted 50 sacks Class C Neat cement at 896'. POOH with tubing. WOC 4 hours. RIH with tubing - did not tag. Spotted 50 sacks Class C Neat cement at 896'. POOH with tubing. Shut well in for night. WOC.

6-17-2003 - RIH with tubing and tagged plug at 788'. Circulated hole with plugging mud. Spotted 50 sacks Class C Neat cement at 788'. POOH with tubing. WOC 4 hours. RIH with tubing - cement still soft. POOH with tubing and cleaned cement out of last joint. Shut well in for night. WOC.

6-18-2003 - RIH with tubing and tagged plug at 620'. Circulated hole with plugging mud. Pulled up hole to 448'. Spotted 50 sacks Class C Neat cement. POOH with tubing. WOC 4 hours. RIH with tubing - cement still soft. POOH with tubing. WOC 1 hour. RIH with tubing - cement still soft. POOH with tubing. Shut well in for night. WOC.

6-19-2003 - RIH with tubing and tagged plug at 342'. POOH with tubing. Rigged down tubing equipment and floor. Nippled down BOP. RIH with 2 joints tubing. Circulated 60 sacks Class C Neat cement from 60' to surface and up 13-3/8" casing. POOH with tubing. Cut off wellhead. Rigged down pulling unit and plugging equipment. Installed regulation abandonment marker. PLUGGED AND ABANDONED - FINAL REPORT. Plugging completed 6-18-2003.
