Comments on Inspection:

Flow line manifold at southwest corner of the tank battery on this location has an active leak from a corrosion hole on the north face of the manifold. Fluids are pooled in this corner of the battery. All fluids are contained inside the bermed area. Release is less than 5 barrels of produced fluids.

Remediation of the release impacted area is required. Notify NMOCD District 2 Office when remediation is complete.
