Cemented with 475 sx LiteCrete + 2 pps D153 + 2 pps D24 + 0.05 gps D604 + 0.03 gps M45 + 0.04 gps D801 lead (10.2 ppg, yld 2.41). 375 sx LiteCrete + 2 pps D153 + 2 pps D24 + 0.05 gps D604AM + 0.03 gps M45 + 0.04 gps D801 tail (10.5 ppg, yld 2.23). TOC by temperature survey 2920'.
