Follow up to cementing of Surface Casing approved 7-25-14 due to lost circulation zone:

Run 12 jts 13 3/8, 48# H-40 STC casing with DV tool. Pumped 550 sks with no returns, Open DV tool, pumped additional 300 sks C+ Neat and 20 bbl seal bond with no returns. Wait on cement, run temperature survey, top of cement at 180'. Run 1", tagged at 160', pumped 50 sks Class C with 2% calcium, no returns. Wait on cement. Run 1", tagged at 120', pumped 175 sks Class C with 2% calcium, Circulated 6 bbls to surface. Copy Temperature log attached.


