We propose to drill to 1250' to test the Seven Rivers formation. We will drill a 12" hole to 340' and set 8 5/8" 24# casing, reduce hole to 7 7/8" and drill on to 1250'. We will set 4 1/2" 10.50# production casing and cement with approximately 300 sx. We do not anticipate gas at this depth and will not set up a blowout preventer program at this time.


