Production from these wells goes through gas production units located at each well site. The condensate is produced to the respective steel oil tank(s) and produced water is produced to the respective fiberglass water tank(s) (see attached flow diagram for each location for further detail). Both water and oil are currently being trucked off of location. Condensate sales are by tank gauge method.

The gas production is measured at each battery location using EFMs before entering the main gas line. The combined gas stream will travel to a BOPCO check meter (Mtr ID: 169LAT) then to the Enterprise Sales meter (Mtr #68816). Both meters are located inside Big Eddy Unit boundaries, NENE Section 15, 21S-28E

Individual well allocation meters, check meter and sales meter are calibrated on a quarterly schedule. All allocation and check meters are Total Flow EFMs. Gas allocation and sales meters will meet Onshore Order 5 & API standards for gas measurement.

Allocation of production is based off of the sales volume recorded at the Enterprise sales meter and the allocation meter at each well site. Each well is assigned an allocation factor by dividing the individual well metered volume by volume recorded on the check meter (169LAT). Royalties are paid based off allocated gross production volumes.

At this time, wells #150 and #168 are shut in. Big Eddy Unit #150 was shut in due to mechanical issues. When these issues are resolved, the well will be returned to production and deliver into this pipeline. Well #168 is a State well and was shut in soon after completion. Once approval has been received to commingle the production, this well will also begin producing into the system. Data on the attached well list is based on previous performance; the wells should produce at that level once returned to production.

Summary:

The commingling of production is in the interest of conservation and minimizing waste. BOPCO, L.P. believes this will result in the most effective and economic means of producing the reserves in place from the affected wells and will not result in reduced royalty or improper measurement of production. The proposed commingling will reduce surface facility footprint and overall emissions.

BOPCO, L.P. understands the requested approval will not constitute the granting of any right-of-way or construction rights not granted by the lease instrument.

Condition of Approval

Commingling of Lease and Unit production and Off Lease measurement and Sales

1. This approval is subject to like approval by the New Mexico Oil Conservation Division.
2. This agency shall be notified of any spill or discharge as required by NTL-3A.
3. This agency reserves the right to modify or rescind approval whenever it determines continued use of the approved method may adversely affect the surface or subsurface environments.
4. This approval does not constitute right-of-way approval for any off-lease activities. Within 30 days, an application for right-of-way approval must be submitted to the Realty Section if not already done.
5. Approval for combining production from various sources is a privilege which is granted to lessees for the purpose of aiding conservation and extending the economic life of leases. Applicants should be cognizant that failure to operate in accordance with the provisions outlined in the Authorized Officer's conditions of approval and/or subsequent stipulations or modifications will subject such approval to revocation.
6. Gas measurement for allocation must be measured as per Onshore Order #5 for sales meters.
7. All gas subject to royalty shall be measured as per federal regulations and shall be reported to ONRR as required. All gas which is vented, flared or used on lease shall be reported as per NTL-4A to ONRR. All gas which is vented or flared shall be subject to royalty, unless prior approval was given by the authorized officer.
8. This agency shall be notified of any change in sales method or location of sales point.
9. Additional wells and/or Leases, Units or CAs require additional commingling approvals.
10. Notify this office 24 Hrs. prior to any meter proving to allow time for an inspector to witness.
