

Corners rounded off to gain more in reclamation since these areas are not used for daily operations. IR followed plan in AAPD with IR added to the south side taking to a 3:1 slope. Pad is bermed.

Remaining surface needed for daily operations is 185' x 205' or 0.87 acres.

Other information: well pad clean of spills, pump jack shale green, and secondary containment netted.
