




IR on all sides of location. Location bermed, slopes greater than 3:1, rips across the slope, corners rounded off to reclaim areas not needed for daily operations.

Remaining surface needed for daily operations is 145' x 240' including road running through location or 0.79 acres.

Other information: well pad clean of spills, pump jack shale green, and secondary containment netted.
