Interim reclamation was completed on 10/15/15 as described below:

- The caliche pad was reduced as shown on the attached diagram. The extra caliche was used to repair existing lease roads.
- Subsoil was pushed from fill side into cut side and contoured to prevent erosion and ponding.
- Seedbed was prepared and affected area seeded with native vegetation using BLM seed mixture No. 2, for sandy sites per the COAs.
- 1.5 ft. berm created around entire reclaimed area using existing material.
- Site will be monitored until successful reclamation is achieved.


