CHEVRON HAS CHOSEN TO INSTALL A LOCAL GAS COMPRESSOR WITH ANCILLARY EQUIPMENT FOR GAS LIFT INJECTION. THE EQUIPMENT IS EXPECTED TO BE ON THE WELL PAD LOCATION FOR TWO YEARS POST FIRST PRODUCTION. IN ORDER TO MAINTAIN EQUIPMENT ACCESS FOR MAINTENANCE AND EQUIPMENT REMOVAL, CHEVRON IS REQUESTING AN EXTENSION TO THE CURRENT INTERIM RECLAMATION PLAN. AT THE END OF THE TWO YEAR PERIOD OR SOONER PENDING GAS LIFT NEED, WE WILL EXECUTE THE INTERIM RECLAMATION PLAN AS PROPOSED ORIGINALLY IN THE APD. PETE RODRIQUEZ/CONSTRUCTION REPRESENTATIVE WITH CHEVRON HAS DISCUSSED WITH JIM AMOS/BLM.
