3/28/16 - NU BOP. Latched on to RBP and TOOH.

3/29/16 - RIH with GR/JB to 2614'. Set a 4-1/2" CIBP at 2614'. Tagged CIBP. Loaded hole. Tested casing to 500 psi. Spotted 25 sx Class "C" cement on top. Calc TO C 2070'. Spotted 28 sx Class "C" cement at 1208'. WOC. Tagged at 830'. ND BOP.

3/30/16 - Perforated 4 holes at 300'. Pumped 60 bbls brine down 4-1/2" casing. No circulation out 7" x 4-1/2" valve. Pumped 60 sx cement up to surface. No circulation. Dug out cellar with backhoe. 7" casing was rotted out all the way around. Cut off wellhead. 4-1/2" and 7" were standing full of cement. Installed dry hole marker. Filled cellar. **WELL IS PLUGGED AND ABANDONED.**
