Cimarex respectfully requests approval to shut-in production for the Bradley Federal Com 1 due to pipeline maintenance and pipeline section replacements of the Transwestern Pipeline. This well was shut in February 25th 2016. Transwestern anticipates the maintenance project to be completed by January 1st, 2017. Cimarex is reviewing other delivery point options with DCP. Other delivery point routes may require DOT compliance work which could take several months to complete. when an alternate route is determined & wells are returned to production a sundry will be submitted for approval.
