12/13/15 Per BLM's conditions of approval, we performed a Bradenhead squeeze of the 9-5/8" x 7-5/8" casing annulus. Pumped 435 sacks (200 BBLS) of class H lead cement and displaced with 2 BBLS of fresh water. Followed up with an IBC-CBL run post-remediation. We ran Schlumberger's CBL & IBC from 10,450' MD (4,250' TOC before remediation ACCORDING TO Temp Log) to Surface. The CBL & IBC Logs were emailed to Chris Walls.

The IBC-CBL shows TOC around 1,500' MD (where the amplitude begins to stay consistently below the 20 mV indicating cement coverage). There is more than 2,710' of cement lapped inside the 9-5/8" casing shoe at 4,210' MD (minimum BLM required cementing top at 3,610 ft; 600 ft inside 9-5/8" casing shoe), based on the CBL & IBC logs COP recommends no further remediation.
