THIS SUNDRY NOTICE SERVES THE PURPOSE OF NOTIFYING THE BLM THAT THE 35 MILE LONG CRAWFORD LATERAL OPERATED BY TRANSWESTERN PIPELINE COMPANY LLC WAS SHUT DOWN ON 12/10/2015 DUE TO ANOMALIES DISCOVERED FROM ITS IN LINE INSPECTION. TRANSWESTERN CONTINUES TO ASSESS THE ANOMALIES AND HAS INFORMED CHEVRON USA INC THAT THERE WILL BE NO SERVICE AVAILABLE ON THE CRAWFORD LATERAL UNIT UNTIL FURTHER NOTICE.
