1. Page 3 - Candidate Conservation Agreement (Last paragraph)

Since the CCA program is a voluntary program, Burnett does not feel that this should be a condition of approval on an APD.

2. Page 14 - Watershed

Because this well location is a low cave/karst occurrence area we do not feel that this condition is necessary since the risk is low. Berming a well pad will also create ponding issues during rainy season.
