On 11/30/16, MIRUSU. TOH w/rods, pump, & tbg. Set 5-1/2" RBP @ 1800'. Loaded csg w/10# brine & PT 5-1/2" csg & RBP to 1000 psi, test failed. Located csg leak just below ground level. Set 5-1/2" PKR @ 31' & PT 5-1/2" csg & RBP to 1000 psi-OK. Plan to repair leak while RBP is in hole. Released rig on 12/2/16.
