On 10/14/16, MIRUSU. TOH w/rods, pump, & tbg. Set 5-1/2" RBP @ 1000'. Discovered hole in 5-1/2" csg just below ground level. Set 5-1/2" PKR @ ~31' & PT 5-1/2" csg & RBP to 2000 psi-OK. Released rig on 10/17/16. Plan csg repair.

On 10/21/16, MIRUSU. Dig out wellhead & cut off 8-5/8" csg & 5-1/2" csg w/hole. Weld on new 5-1/2" csg collar & replacement 5-1/2" csg sub. Weld 5-1/2" & 8-5/8" csqs to wellhead. RDWOU. On 12/5/16, MIRUSU. Retrieved RBP @ 1000' & TOH. Landed 2-7/8" production tbg @ 3205'. Ran pump & rods. Released rig on 12/6/16.
