12/29/16 – RIH with GR/JB and tagged at 3235'. Needed to get down to 3456' as per Bob Byrd with NMOCD. RIH with tubing spotting at 3456'. Spotted 15 sx Class "C" cement. Did not tag. Spotted 15 sx Class "C" cement.

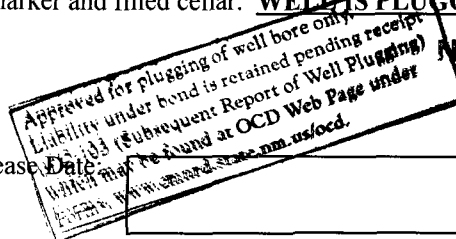
12/30/16 – Tagged TOC at 3035'. Circulated 50 bbls of salt gel. Perforated at 1937'. Squeezed with 55 sx Class "C" cement up to 1837'. WOC. Tagged TOC at 1805'. Bob Byrd with NMOCD ok'd to spot at 1374'. Spotted 15 sx Class "C" cement up to 1150'. Perforated at 956'. Squeezed with 30 sx Class "C" cement up to 856'.

1/3/17 – Tagged plug at 788'. Spotted 15 sx Class "C" cement plug from 399' to 178'. Perforated at 60'. Pumped down 4-1/2" and circulated 10 bbls. Pumped 20 sx Class "C" cement and circulated out surface 8-5/8" x 4-1/2". ND BOP.

1/4/17 - Dug out cellar and cut off wellhead. Installed dry hole marker and filled cellar. **WELL IS PLUGGED AND ABANDONED.**
