Reverse circulation. 12/16/16 Tag'd cmt @ 5922'. Pressure tstd csg, held 500 psi. Pump'd 25 sx class C cmt w/ 2% CACL @ 5100-4847'. WOC. 12/20/16 Tag'd plug @ 4671'. Spot'd 45 sx cmt @ 2874' & displaced to 2370'. WOC. Tag'd plug @ 2395'. 12/20/16 Spot 25 sx @ 1375' & displaced to 1122'. WOC. 12/21/16 Tag'd plug @ 1278' (w/ BLM Witness). Perf'd csg @ 640', pressured up on perms. Spot'd 70 sx cmt @ 690'-surface. ND BOP. Pump'd 55 sx cmt in 5 1/2 & 8 5/8 annulus. Rigg'd down and moved off.
