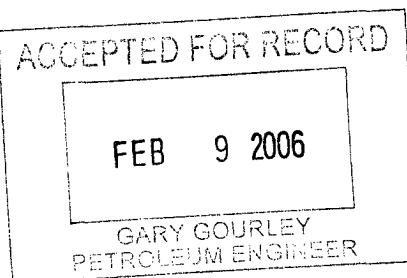

1/30/06 Resumed drilling at 7:00 AM. Set 13-3/8" 48# H-40 8R ST&C casing at 380'. Cemented with 200 sx Premium Plus + 2% CaCl + 1/4#/sx Flocele (yld 1.35, wt 14.8). Tailed in with 200 sx Premium Plus + 2% CaCl (yld 1.35, wt 14.8). Cement circulated to surface. Tested casing to 600 psi for 30 min. WOC 18 hrs. Reduced hole to 8-3/4" and resumed drilling.
