EOG Y Resources, Inc. plans to add perforations in the Yeso as follows:

1. MIRU all safety equipment as needed. NU BOP.
2. POOH with production equipment. Visually inspect tubing and replace if necessary. Load hole as needed to maintain well control.
3. Correlate to open hole logs. Perforate Yeso 2550'-2625' with 4 JSPF using 90 degree phasing for a total of 301 shots, 75' net pay.
4. RD wireline and RU spoolers.
5. RIH with TEC cable and BHP sensor. Once sensor is on bottom and working RD spoolers.
6. After Boyd #15H frac will evaluate perforations.
7. RDMO.




